Hermitage Academy is part of the North East Learning Trust and both are aware of the general duty under the Equality Act 2010 to:

The Accessibility Plan has been drawn up in consultation with stakeholders and covers the period from September 2021 – August 2024.

We are committed to providing a fully accessible environment which values and includes all students, staff, parents/carers, and visitors regardless of their age, education, physical, sensory, social, spiritual, emotional, and cultural needs. We are committed to challenging negative attitudes about disability and accessibility and to developing a culture of awareness, tolerance, and inclusion.

The Accessibility Plan will contain relevant actions to:

- Improve awareness of Equality and Inclusion.
- Improve access to the physical environment of the school, adding specialist facilities as necessary. This covers improvements to the physical environment of the school and physical aids to access education.
- Increase access to the curriculum for students with a disability, expanding the
  curriculum as necessary to ensure that students with a disability are as, equally,
  prepared for life as are the able-bodied students; (If the school fails to do this,
  they are in breach of the Equality Act 2010). This covers teaching and learning
  and the wider curriculum of the school such as participation in after-school
  clubs, leisure and cultural activities or school visits. It also covers the provision
  of specialist aids and equipment, which may assist these students in accessing
  the curriculum.
- Improve the delivery of written information to students, staff, parents/carers, and visitors with disabilities. Examples might include handouts, timetables, textbooks and information about the school and any events. The information should be made available in various preferred formats within a reasonable time frame.
- Work with appropriate organisations to ensure accessibility is appropriate for all students, staff, and visitors.
