1. Introduction

Hermitage Academy is part of the North East Learning Trust and the uniform policy supports the high standards of the Trust and the Academy. At Hermitage Academy we believe that a school uniform plays an important role in creating a focused and respectful learning environment. Our uniform policy is designed to promote equality, reduce distractions, and instill a sense of pride and belonging among students. By wearing the correct uniform, students represent not only themselves but also the values and community of our school. This policy outlines the expectations for student dress and appearance, ensuring consistency and clarity for all members of the school community.

2. Aims

We believe that a clearly defined Academy uniform is important because it:

• Promotes Equality

To create a sense of fairness and reduce peer pressure by minimising visible economic and social differences among students.

• Encourages a Sense of Belonging

To help students feel part of the school community and take pride in representing their school.

Supports a Focused Learning Environment

To reduce distractions and support a professional atmosphere that is conducive to learning and achievement.

• Enhances Safety and Security

To ensure students are easily identifiable as members of the school, both on-site and during off-site activities, improving overall safety.

Fosters Discipline and Responsibility

To encourage students to take responsibility for their appearance and to understand the importance of following guidelines and expectations.

• Prepares Students for the Future

To help students develop habits of personal presentation that are important in many workplaces and formal environments.

3. School Uniform

The school uniform requirements are outlined in the table below, along with details regarding which items are optional and which need to be branded.

Note: Trousers purchased elsewhere MUST be the same style and fit as those provided by the uniform supplier.
Skirt	Required	Navy tartan pleated skirt Note: Available from the uniform supplier.
Shorts	Optional	Plain navy formal knee length shorts, of the same material as school trousers, during the summer term are allowed. No jeans, cargo style, leggings, stretchy or tracksuit style. PE shorts, in all styles are not allowed.
Socks/Tights	Required	Socks must be black, navy or dark grey with trousers. They must be ankle length or longer. Plain black, navy or grey tights must be worn with skirts. Note: Can be purchased from any high-street retailer.
Shoes	Required	Plain black, formal, leather or leather style shoes which can be polished. No trainers, plimsolls, pumps, boots, converse shoes, or open toe shoes

permitted. Note: Shoes can b	oe .

4. General Appearance

Hair	Haircuts should not be less than a number 1. Students are not permitted to have tram lines or sculptures in their hair or any extreme hairstyles. Students should not dye their hair an unnatural colour. Hair bands should be thin and not overly decorated e.g. no larger flowers.
Religious Head Coverings	Students may wear religious head coverings or garments (e.g. hijabs, turbans, kippahs) as part of their uniform, provided they are plain black or navy and meet health and safety standards. Religious head coverings can be purchased from Emblematic.
Jewellery	Students are permitted to wear one plain stud, silver or gold in each earlobe. Diamante earrings, plugs and expanders are not allowed. No other jewellery is permitted including necklaces, bracelets or rings. Body piercings that are visible are not allowed, including tongue piercings, nose and eyebrow studs. Parents must ensure that if a child is to have a piercing it must take place at the start of the six weeks' holiday and must be removed on the first day of term. Watches (but not smart watches) are allowed but please ensure they are suitable for a school environment.
Make-Up	Makeup should not be visible. False eyelashes are not to be worn. Lipstick is not to be worn. Nails are not to be painted and false nails are not to be worn.
Tattoos	Tattoos which are visible are not permitted. Any student aged 18 or over with a visible tattoo will need to keep it covered up. It is illegal to have a tattoo below the age of 18.
Clothing	Large fashion belts are not acceptable or part of the Academy uniform. Hoods must not be worn inside the Academy.
Equipment	All students are expected to come to the Academy with: • a bag large enough to carry an A4 file (backpacks are recommended)

- a pencil case containing pen, pencil, ruler, and rubber recommended)
- a PE kit (on PE days)

Tutors and Year Managers will carry out equipment checks regularly Where a student repeatedly fails to bring the correct equipment to the Academy, his/her name will be passed on to the appropriate Year Manager. From then onwards, the Year Manager will apply a range of sanctions to ensure that the student brings the correct equipment to the Academy. These sanctions might include detentions, parental contact, internal exclusions etc.

5. Sixth Form Dress Code

Our dress code is smart office wear which entails:

- Blouse/dress shirt/polo shirt (collared).
- Tailored trousers (no jeans/tracksuits).
- Tailored skirt (minimum knee length).
- Jumper / cardigan.
- Smart shoes (not trainers/pumps).
- No extreme hairstyles. Hair colour and make-up should be subtle.
- Tattoos must not be visible.
- No facial piercing allowed other than subtle ear piercing.
- No extreme levels of jewellery to be worn in school.
- Coats/hoodies/hats should not be worn inside the building.

Students are in a working environment, therefore, strapless or shoulder less tops, short tops which do not meet the waistband of trousers/skirts, short skirts, shorts, plunging necklines, gym wear and vest tops are not appropriate. Clothes that are too tight or revealing (including sports leggings) should not be worn.

The Academy reserves the right to make the final decision on what is acceptable and what is not acceptable.

Pre-Loved School Uniform

In an effort to ensure affordability and ease the financial pressures involved in purchasing uniform for our parents/guardians and their families, the Academy has established links with two charity shops in Chester-Le-Street, St Cuthbert's Hospice, 172 Front Street, Chester-Le-Street, DH3 3AZ and Age UK, 80 Front Street, Chester-Le-Street, DH3 3BB. Both charity shops are willing to receive donations of school uniform that is in good condition and can be re-sold. This partnership will enable us to support families within our community and the important work undertaken by both charities. We also have spare uniform in school that we will issue to students as and when required.

As part of the Home School Agreement_our students and parents/guardians agree to conform to the uniform requirements of the school. Students are expected to wear school uniform unless there is a justified reason as to why they may not. If your child cannot temporarily wear any aspect of the uniform, then parents/carers should inform the school, in writing, the reasons as to why.

If parents/guardians or students are in doubt about whether or not a particular article of clothing is suitable, or before making any decisions about altering hair colour or style, we ask that they contact their child's Year Manager prior to any change.

The Head of School, in accordance with the Behaviour Management Policy will issue appropriate sanctions to students who persistently do not comply with the Uniform Policy.
